

ARTICLES OF INCORPORATION

OF

ORS 10-18 (FL), INC.



The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Company") is: QRS 10-18 (FL), INC.

SECOND: The street address, wherever located, of the principal office and the mailing address of the Company is c/o W.P. Carey & Co., Inc., 620 Fifth Avenue, New York, New York 10020.

THIRD: The number of shares that the Company is authorized to issue is 100 (one hundred), all of which are of a par value of \$.01 dollars each and are of the same class and are common shares.

FOURTH: The street address of the initial registered office of the Company in the State of Florida is c/o The Prentice-Hall Corporation System, Inc., 1201 Hays Street, Suite 105, Tallahassee, Florida 32301.

The name of the initial registered agent of the Company at the said registered office is The Prentice-Hall Corporation System, Inc.

The written acceptance of the said initial registered agent, as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

SIXTH: The purpose for which the Company is organized shall include the authority of the Company to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act and the Company shall have all of the general powers granted to corporations under the Florida Business

Corporation Act, whether granted by specific statutory authority or by construction of law.

SEVENTH: The duration of the Company shall be perpetual.

EIGHTH: The Company shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to on or covered by said provisions and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, vote of Shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

NINTH: Whenever the Company shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.
