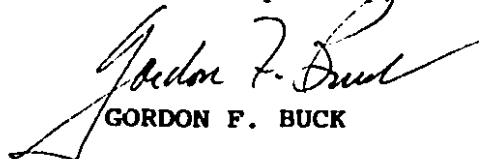

The undersigned, acting as incorporator(s) of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

2. Duration. The period of its duration is perpetual.
