Pursuant to the provisions of Section 607.1006, Florida Statutes, K & K GLASS, INC. (the "Corporation"), adopts the following amendments to its Articles of Incorporation:


- A. The name of the Corporation is: K & K GLASS, INC.
- B. The Articles of Incorporation of the Corporation were filed on February 20, 1995, and assigned document number P95000014249.
- C. Article I, of the Articles of Incorporation of the Corporation, in its entirety, is hereby revoked, declared null and void and of no further effect and, in lieu thereof, the following article is adopted, approved and ratified:

**ARTICLE I
NAME**

Section 1.1. Name. The name of the corporation is DMST HOLDINGS, INC.
