

ARTICLE I

The name of the corporation is DESIGN TECH INTERIOR SERVICES, INC.

ARTICLE II

The duration of the corporation shall be perpetual, and the date and time of the commencement of corporate existence shall be February 16, 1995.

The general purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
