ARTICLES OF AMENDMENT AND TO ARTICLES OF INCORPORATION OF FIREHOUSE RESTAURANT GROUP, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Firehouse Restaurant Group, Inc.

SECOND: Article III of the Articles of Incorporation of Firehouse Restaurant Group, Inc. is hereby amended in its entirety to read as follows:

ARTICLE III. CAPITAL STOCK

- (a) The total number of shares of stock that the Corporation shall have authority to Issue is 200,000 consisting of (i) 100,000 shares of Voting Common Stock ("Voting Common Stock"), and (ii) 100,000 shares of Non-Voting Common Stock ("Non-Voting Common Stock"). The rights, preferences, powers, privileges, and the restrictions, qualifications and limitations of the Non-Voting Common Stock are identical with those of the Voting Common Stock other than in respect of voting rights as set forth herein, and for all purposes under these Articles of Incorporation, other than voting rights, the Voting Common Stock and the Non-Voting Common Stock shall together constitute a single class of shares of the capital stock of the Corporation.
- (b) Voting Rights.
 - i. Voting Common Stock. Except as otherwise required by law, the holders of the Voting Common Stock shall exclusively possess all voting power, and each holder of Voting Common Stock shall have one vote in respect of each share of Voting Common Stock held of record by such holder for the election of directors and on all matters submitted to a vote of shareholders of the Corporation except with respect to matters, if any, with respect to which under applicable law the holders of Non-Voting Common Stock are entitled to vote as a separate class.
 - ii. Non-Voting Common Stock. Except as otherwise required by law, shares of Non-Voting Common Stock shall have no voting rights.

THIRD: The date of this amendment's adoption is Dec 24-, 2014.

FOURTH: This amendment was adopted by the Board of Directors and shareholders of this Corporation. The number of votes cast by the shareholders was sufficient for approval.
