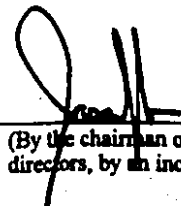

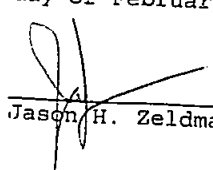
ARTICLES OF INCORPORATION

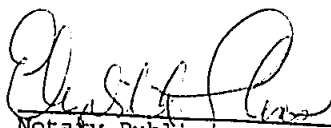
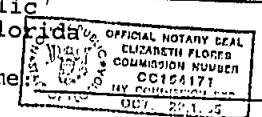

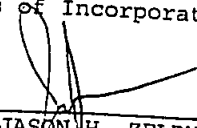
