Subchapter S Corporation

The year 2005, the TENTH full year of operations of Safeguard Services Southeast, Inc. was as expected. The debt of the company was paid down from \$100,000 to \$60,000 during 2005. The interest rate currently being paid is 6% the same as last year. The contract with Abbott which is now the main source of income for the company calls for a return of \$1.40 per unit/per night used and began in June of 2004 and will run December 31, 2011. Then, the Contract will be renegotiated. The unit/night use at the Abbott properties each year for the past four years was in excess of 30,000 unit/nights.

The operating income and expenses for 2005 were as expected. There was a net profit of \$3,374.27 in 2005 against a profit of \$1,495.19 in 2004.

No dividends were paid during 2005. No dividend is anticipated to be paid in 2005. Most cash flow will be used pay to down the current debt.

At the close of the year there was \$23,608 cash in Banks, \$6,200 less than last year.
