The undersigned incorporator, who is an adult able to enter into contracts in Florida, desiring to form a corporation under Chapter 607 of Florida statutes, adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be LegaScan, Inc.

ARTICLE VIII: DIRECTORS


Corporate business shall be managed by the shareholders of the corporation, rather than by a board of directors.




