ARTICLES OF INCORPORATION

OF

SDA GLOBAL, INC.

ARTICLE I: NAME

The name of this corporation is SDA GLOBAL, INC.

ARTICLE II: NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to manufacture, purchase, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services, of every class, kind and description, to engage in any other lawful business; and to do any and all acts and things necessary, convenient, expedient, ancillary or in aid to the accomplishment of the foregoing.

ARTICLE III: STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having no par value.

ARTICLE IV: MANAGEMENT

The business of the corporation shall be managed by the shareholders of this corporation rather than by a Board of Directors.

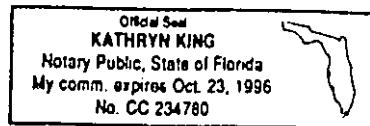


