I, the undersigned, hereby declare, for the purpose of establishing a Corporation under the laws of the State of Florida, by and under the provisions of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, that I have agreed upon the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be TOP CENTER IMPORT & EXPORT, INC.

ARTICLE II

Duration of the corporation shall be eternal.

ARTICLE III

The corporation will engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
