ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation is ON TARGET EVENTS, INC. (the "Corporation").
- SECOND: The principal office address and mailing address of the Corporation is 5941 North Bay Road, Miami Beach, Florida 33140.
- THIRD: The Corporation is authorized to issue 10,000 shares of common stock, par value \$.01 per share.

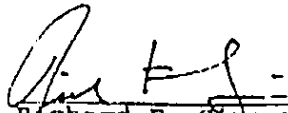
