

ARTICLES OF INCORPORATION OF
PROFESSIONAL FOLLOW UP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation shall be: PROFESSIONAL FOLLOW UP, INC.

ARTICLE TWO
INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address of this corporation shall be: 678 Sandpine Circle, Suite 2211, Deerfield Beach, Florida 33441.

ARTICLE THREE
PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of promoting customer loyalty and relations.
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
3. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR
SHARES

The aggregate number of shares which the corporation is authorized to issue is five hundred (500). Such shares shall be of a single class, and shall have a par value of \$1.00 per share, and all shares when issued shall be paid for and shall be fully non-assessable.
