The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Island Travel Plazas, Inc.

ARTICLE VII-BYLAWS


The Board of Directors shall adopt Bylaws for this Corporation and may from time to time modify, alter, amend or rescind the same


