The undersigned, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is "LDWR, INC." (hereinafter referred to as the "Corporation"). The principal office and mailing address of the Corporation is 2652 N.W. 46th Street, Boca Raton, Florida 33434.

**ARTICLE II**

**PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

**ARTICLE III**

**TERM**

The term for which the Corporation shall exist shall be perpetual and it will commence three days prior to the filing of these Articles of Incorporation with the Secretary of State of Florida.

**ARTICLE IV**

**CAPITAL STOCK**

The aggregate number of shares which the Corporation shall have the authority to issue is 500 shares of common stock, par value \$1.00 per share.

**ARTICLE V**

**INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office and registered agent of the Corporation in this state is 2652 N.W. 46th Street, Boca Raton, Florida 33434 and the name of the initial registered agent of the Corporation at that address is Joseph R. Reamer.

**ARTICLE VI**

**INITIAL BOARD OF DIRECTORS**

The Corporation shall initially have two directors. The number of directors may be either increased or decreased from time to time as determined by the Bylaws of the Corporation, but shall never be less than one.



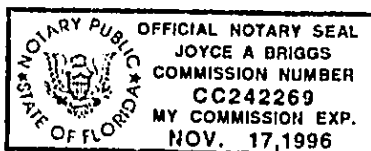
