ARTICLE I. NAME

The name of this corporation is FIREBLOCK INTERNATIONAL, INC. The principal place of business is 214-A North Third Street, Leesburg, Florida, 34748. The mailing address is Post Office Box 491635, Leesburg, Florida, 34749-1635.

ARTICLE II. DURATION

FEB 15 1995

This corporation shall begin its existence February 15, 1995.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

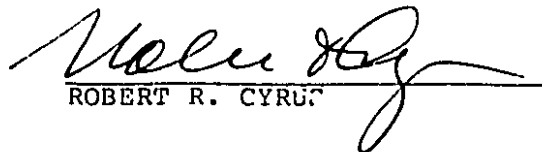
ARTICLE IX. INDEMNIFICATION

ARTICLE X. AMENDMENT

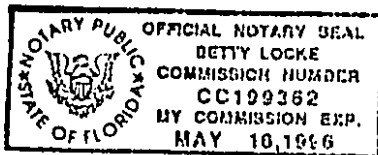
