# ARTICLE I Name of Corporation

The name of the corporation is P.C. SUPPORT SERVICES, INC.

#### ARTICLE II

# Corporate Existence

This corporation is organized pursuant to chapters 607 of the Florida statutes, and shall have a perpetual existence.

#### **ARTICLE III**

# Purpose of Business

# **Directors**

Any director of this corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he is also a director of such subsidiary or controlled company.

These Articles of Incorporation may be amended, changed, altered or repealed only by the stockholders.
