### ARTICLES OF INCORPORATION

OF

EFFECTIVE DATE PHIERMAN'S PROFESSIONAL SERVICES, INC.

> The undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associates themselves together to form a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation is Spiderman's Professional Services, Inc. (hereinafter referred to as the Corporation).

#### **ARTICLE II**

The specific type of business the company shall be conducting shall be waterproofing and window cleaning.

The general nature of the business to be transacted by the Corporation is to engage in the transaction of any and all lawful business for which corporation may be incorporated under the laws of the State of Florida, including:
