

## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

### **ARTICLE 1 - NAME**

The name of the Corporation is **COIN OPERATED INDEPENDENT NUTRITONAL SYSTEMS, INC.** 

### **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

### **ARTICLE 3 - PRINCIPAL OFFICE**

The address of the principal office of this corporation is 5525 Commerce Drive, Suite 7, Orlando, Florida 32839 and the mailing address is Post Office Box 621478, Orlando, Florida 32862.

### **ARTICLE 4 - INCORPORATOR**

### **ARTICLE 5 - PRESIDENT**

The initial President of the corporation shall be William L. Nichols whose address shall be the same as the principal office of the corporation.



### ARTICLE 6 - CORPORATE CAPITALIZATION

- 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED (7,500)** shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).
