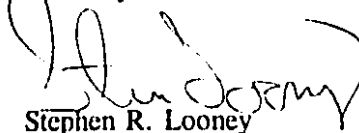

ARTICLES OF INCORPORATION

EFFECTIVE DATE

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be BFE, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 601 South Lake Destiny Road, Suite 260, Maitland, Florida 32751.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE IV - INITIAL REGISTERED OFFICE

AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 601 South Lake Destiny Road, Suite 260, Maitland, Florida 32751.

The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this Corporation at that

address is Daniel E. Watkins. The Board of Directors may from time to time designate a new registered agent.

ARTICLE V - INCORPORATOR

ARTICLE VI - INITIAL BOARD OF DIRECTORS

- A. The initial number of directors of this Corporation shall be two (2).
- B. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of this Corporation, but shall never be less than one (1).

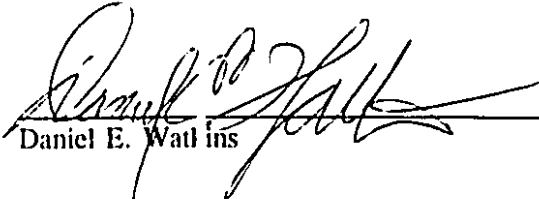
ARTICLE VIII - DATE OF EXISTENCE
