The corporation shall have two directors initially, whose names and addresses are:





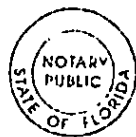
