ARTICLES OF INCORPORATION OF GATES MARKETING GROUP, INC.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act hereby adopts The LANGUE FLORIDA Articles of Incorporation:

ARTICLE ONE NAME

The name of the corporation is Gates Marketing Group, Inc.

ARTICLE TWO **DURATION**

The term of existence of the corporation is perpetual.

ARTICLE THREE **PURPOSE**

The general purposes for which the corporation is organized are the wholesale and retail sales of water, air and emission purification systems and to transact any other lawful business for which corporations may be incorporated under the laws of the State of Florida.
