

Articles of Incorporation

of

Theodore Johnson, Inc.



Article I

The corporation is Theodore Johnson, Inc.

Article II

This corporation shall be in perpetual existence unless sooner dissolved according to law.

Article III

The general purposes for which the corporation is organized are as follows:

- A. To manufacture, purchase or otherwise acquire and own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, and to invest in goods, wares, merchandise, real and personal property and services.
- B. Generally to make and perform contracts of any kind and description, and for the purposes of attaining any of the objects of the corporation, to do and perform any other acts or things, including the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

Article IV

The maximum number of shares that this corporation is authorized to have outstanding at any one time shall be One Hundred (100) shares of common stock, all one class, having a par value of Ten (\$.10) Cents to be paid for in lawful money of the United States or in property, labor or services, which capital stock shall be sold, issued, assigned and transferred only in accordance with the by-laws of the corporation.
