ARTICLES OF INCORPORATION

OF

SANTA ROSA SOUND INVESTMENTS, INC.

ARTICLE ONE - NAME

The name of this corporation is Santa Rosa Sound Investments, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO - DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE THREE - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE FOUR - CAPITAL STOCK

The Corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock.

ARTICLE SEVEN - INITIAL PRINCIPAL OFFICE

ARTICLE EIGHT - INITIAL BOARD OF DIRECTORS

ARTICLE THIRTEEN - AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
