The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

CARRIBEAN SUPPORT & DEVELOPMENT, INC.

The address of the principal office of this corporation shall be 1691 Harbourside Drive, Fort Lauderdale, Florida 33326, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

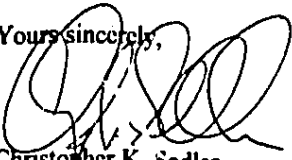
