# ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

### FIRST:

The name of the corporation is Batchie, Inc. The principal office and mailing address of the corporation is 13510 Middle Beach Road, Suite B, Panama City Beach, Florida 32407.
