Name

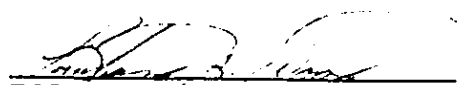

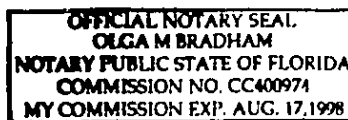
