ARTICLE I - NAME

The name and address of this corporation is: FREDOT, INC., 540 East McNab Road, Suite D, Pompano Beach, FL 33060.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

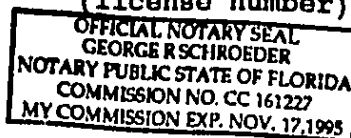
