

STATE OF FLORIDA ARTICLES OF INCORPORATION OF

GUARANTEED, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is GUARANTEED, INC. The principal office and mailing address is 2333 N. State Rd. #7, Suite A, Margate, FL 33063.

ARTICLE II

This corporation is to exist perpetually.

ARTICLE III
