ARTICLES OF INCORPORATION OF LOWER FLORIDA TELECOMMUNICATIONS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE_I

The name of the corporation is LOWER FLORIDA TELECOMMUNICATIONS, INC.

ARTICLE II NATURE OF BUSINESS

The corporation shall be engaged in the business of telecommunications and contracting and any other lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding is One Hundred (100) shares of common stock, each having \$1.00 par value. No holder of shares of the corporation of any class now or hereafter authorized shall have any preferential or preemptive right to subscribe for, purchase, or receive any shares of the corporation of any class now or hereafter authorized, or any options or warrants for such shares, which at any time may be issued, exchanged, or offered for sale by the corporation.

ARTICLE IV DURATION

This corporation shall have perpetual existence.

ARTICLE V REGISTERED AGENT AND ADDRESS

ARTICLE VI DIRECTORS
