## ARTICLES OF INCORPORATION

1, the undersigned, do hereby file these Articles of Incorporation for the purpose of forming a corporation under and pursuant to the laws of the State of Florida, including particularly, Chapter 607, Florida Statutes, and for that purpose, I do hereby certify, declare and set forth as follows, to wit:

#### ARTICLE I - NAME

The name of this corporation is BREINES & KARP, INC.

The address of the principal office of this corporation shall be 3300 PGA Boulevard, Suite 550, Palm Beach Gardens, Florida 33410, and the mailing address of the corporation shall be the same.

#### ARTICLE II - NATURE OF BUSINESS
