ARTICLES OF INCORPORATION

OF

MIAMI CONDOMINIUM TOUR, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. Name. The name of this corporation shall be MIAMI CONDOMINIUM TOUR, INC.
- 2. <u>Duration</u>. This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have a perpetual existence.
- 3. <u>Purpose</u>. The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and State of Florida.
- 4. <u>Capital Stock</u>. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
