#### ARTICLES OF INCORPORATION OF EMERALD LABS, INC.

## Article I - Name and Status

The name of this corporation is EMERALD LABS, INC. The corporation shall be a corporation for profit pursuant to Chapter 607 of Florida Statutes.

## Article II - Principal Office: Mailing Address

The address of the principal office of the corporation is 104 Country Club Drive, West, Destin, Florida 32541. The mailing address of the corporation is P.O. Box 1866, Destin, Florida 32540.

### Article III - Duration

This corporation shall exist perpetually, commencing with the date of filing.

### Article IV - Purpose

This corporation is organized to carry on the operation of producing and marketing chemical products and product application systems, and for the purpose of transacting any or all other lawful business.

### Article V - Capital Stock

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

### Article VI - Shares of Stock

## Article VII - Preemptive Rights

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation shall

be managed under the direction of the shareholders of record, each of whom shall have one (1) vote in the affairs of the corporation for each share of stock of the corporation owned by the said shareholder. The powers and duties conferred or imposed upon directors by virtue of Florida Statues shall be instead conferred or imposed upon the shareholders.
