ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **SUNCOAST PARALEGAL, INC.**, and its principal place of business shall be located at 2533-209 Dolly Bay Drive, Palm Harbor, Florida 34684.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock at One Dollar (\$1.00) par value, which shall be designed as "Common Shares".

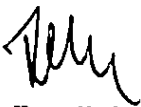
