Article I - Name

The name of this corporation is WATERS' EDGE A.C.L.F., INC.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

The purpose of this corporation shall be to engage in any lawful business not prohibited by the laws of the State of Florida or the United States of America.

Article IV - Capital Stock

This corporation is authorized to issue 5,000 shares of one dollar (\$1.00) par value common stock, which shall be designated "Common Shares". The consideration to be paid for each share shall be in money, property, or services. The Board of Directors shall determine the reasonable value of all consideration, other than money, paid for such shares and their determination, made in good faith, shall be final and conclusive as to such value.

Article V - Preemptive Rights

There shall be no preemptive rights.

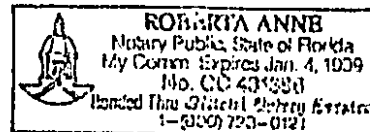
