**ARTICLE I.  
CORPORATE NAME**

The name of this Corporation shall be:

**ARTICLE II.

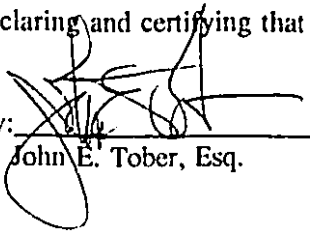

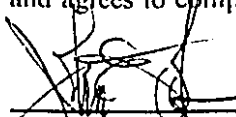
