## ARTICLES OF INCORPORATION FOR

## AMERICAN FAMILY VACATIONS, INC

The undersigned incorporators, being natural persons of sound mind, hereby file these Articles of Incorporation under the laws of the State of Florida.

#### article 1

- A. The general nature of the business to be transacted shall be to engage in the business of purchasing, producing, acquiring, owning, leasing, selling, transferring, supplying, contracting, servicing, encumbering, generally dealing in all types and kinds of travel, travel related products, accessories, or any items or supplies related to or used in connection with the travel industry.
- B. To purchase, acquire, own, lease, sell, transfer, encumber, repair, renovate and service all types of property, both real and personal connected in any manor whatsoever with the operation of this business.
- C. To have one or more offices, stores or places of business from which to conduct its business and promote it's objectives from within and /or outside the state of Florida without restrictions as to place and amount.
- D. For any other lawful purpose for the corporation to enter into as well as, make and perform contracts of every kind with any person, firm association, corporation, municipal body, county, territory, state, country or

government and without limitation to borrow money and contract debts when necessary in the transaction of its business for the exercise of its corporate rights, privileges or franchises, or for any other lawful purpose of its incorporation; to issue checks, bonds, promissory notes, drafts, bills of exchange, debentures and other obligations and evidences of indebtedness, secured or unsecured, payable at a specified time or times for any all objects and purposes of this corporation.

E. To do all and everything necessary and proper for the legal accomplishment of any of the purposes or the attaining of objectives or the furtherance of any of the powers enumerated in this certificate of incorporation or any amendments thereof, necessary or incidental to the protection and / or benefit of this corporation.

The foregoing paragraphs shall be construed as enumerating both the objects and powers of this corporation; and it is hereby expressly provided that the foregoing shall not be held to limit or restrict in any manner the powers of this corporation to do any and all things that are lawful in the state of Florida.

#### ARTICLE II

### CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and to have outstanding at any one time shall be 7,500 shares of common stock having a par value of \$1.00 each.

This corporation is to exist perpetually in the state of Florida.

#### AMENDMENTS

stockholder shall elect to sell or dispose of any shares of stock owned by him, the corporation shall have first refusal right, at the same bid price, to acquire said shares/being disposed of.
