ARTICLES OF INCORPORATION

We, THE UNDERSIGNED SUBSCRIBERS, agree to form a corporation under the laws of the State of Florida and hereby make, subscribe, acknowledge and file these Articles of Incorporation as follows:

ARTICLE T. CORPORATE NAME

The name of the corporation shall be: Hike Enterprises, Inc.
