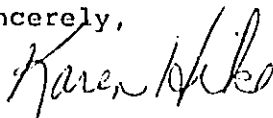

We, THE UNDERSIGNED SUBSCRIBERS, agree to form a corporation under the laws of the State of Florida and hereby make, subscribe, acknowledge and file these Articles of Incorporation as follows:

ARTICLE I. CORPORATE NAME

The name of the corporation shall be: Hike Enterprises, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation, which is also the mailing address of the corporation, is 12078 Cranefoot Drive, Jacksonville, Florida, 32223.

ARTICLE III. DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE IV. PURPOSES

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue and have outstanding 100 shares of \$1.00 par value stock. Holders of common stock of this corporation may transfer their shares to any other party in the manner provided by law, subject to any provisions set forth in the By-Laws of this corporation.

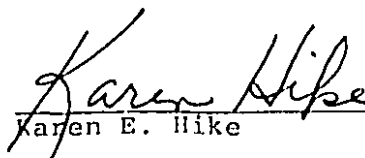

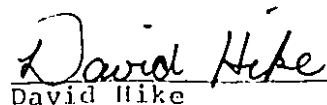
