## ARTICLES OF INCORPORATION OF B. G. MEDICAL OF MIAMI, INC.

The undersigned subscriber to these Articles ASEE, FLORIDA Incorporation, desiring to form a corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

## ARTICLE I

The name of the corporation shall be: B. G. MEDICAL OF MIAMI, INC.

## ARTICLE II DURATION
