NAME

The name of this corporation is Sports Awards, Inc.

ARTICLE II

EFFECTIVE DATE

ARTICLE III

CAPITAL STOCK

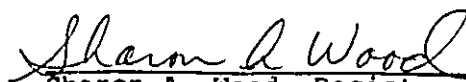
