ARTICLES OF INCORPORATION
OF
KOMA OUTDOOR SIGNS, INC.

ARTICLE I: Name

The name of this corporation is KOMA OUTDOOR SIGNS, INC.

ARTICLE II: Nature of Business

This corporation may engage in any activity or any business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III: Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 100 shares of common stock, each share having a par value of \$5.00.

ARTICLE IV: Address

The initial street address of the principal place of business of this corporation in the State of Florida is 6117 Glen Barr Avenue, Orlando, Florida 32809, but may from time to time move the principal place of business to any address in Florida.

ARTICLE V: Preemptive Rights

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase

any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquired shares of any such unissued or treasury shares.

ARTICLE VI: Directors

The corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by the By-Laws but shall never be less than one. 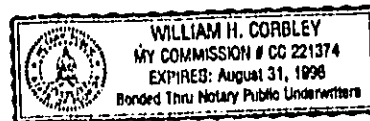
