ARTICLES OF INCORPORATION

ARTICLE I

FEB 2 0 1995

The name of the corporation shall be WESLEY'S 1/2 PRICE BEDDING, INC. and its principal place of business shall be located at 5130 U.S. Highway 27 North, Sebring, Florida 33872.

ARTICLE II

The general character of the business to be transacted by the corporation is wholesale/retail sales.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock, each share having the par value of One Dollar (\$1.00). Authorized capital may be issued in return for cash, services or property, at a just value to be determined by the Board of Directors of this corporation at any meeting.

ARTICLE IV

Cumulative voting for directors shall NOT be permitted.

ARTICLE V

This corporation shall exist perpetually and its existence shall begin on the 20th day of February, 1995.

ARTICLE VI

The initial registered office of the corporation shall be 5130 U. S. Highway 27 North, Sebring, Florida 33872 and the name of the initial registered agent of this corporation and address shall be ROBERT JOHNSON,

ARTICLE VII

The following person shall serve as the first Board of Directors of the corporation, subject to these Articles of Incorporation, the By-Laws of the corporation, and the laws of the State of Florida, and shall hold office until successors have been elected and qualified: ROBERT JOHNSON.

RTICLE VIII

The name and street address of the incorporator of the corporation is: ROBERT JOHNSON, 5130 U. S. Highway 27 North, Sebring, Florida 33872.

ARTICLE IX

The number of directors of this corporation shall be one (1) or more but shall not be less than the minimum required by Florida Statutes as amended subsequently. Directors may participate in meetings by means of conference telephone or similar communications equipments to the full extent permitted by law.

ARTICLE X

The quorum required for action by the Board of Directors shall be as provided by the By-Laws. Notwithstanding the fact that one

or more of the directors present at the meeting of the Board of Directors may have an interest in any matter pending before the Board, such director or directors shall have the right to vote upon such matter; provided that such interested director or directors first shall have made full disclosure to the other directors present of such interest.

ARTICLE XI

The corporation shall promptly and fully indemnify any stockholder, agent, employee, officer or director of the corporation made a party to an action, suit or proceeding arising out of his position or acts undertaken in such position to the full extent authorized by Florida Statutes.

ARTICLE XII

The By-Laws shall be adopted and amended by the Board of Directors. These Articles of Incorporation shall be amended only by the stockholders entitled to vote a majority of the stock outstanding. Such amendment may be effected at an annual meeting or a special meeting or by signing a written statement manifesting the intention of <u>all</u> stockholders that a certain amendment to these Articles of Incorporation be made.
