OF

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby makes, subscribes and acknowledges these Articles of Incorporation in accordance with the laws of the State of Florida.

**ARTICLE I**

The name of this corporation is **ROBBY CENTRAL, INC..**

**ARTICLE II**

The nature of the business and the objects and purposes proposed to be transacted by the corporation are:

1. To buy and sell, export, import, lease, exchange, and generally deal in machinery and equipment of all kinds and descriptions and to act as agent for others for all or any of said purposes.

2. To engage in the buying, selling, trading, repairing, altering, letting, dealing in, and manufacturing electric machinery and appliances of all kinds and descriptions.

3. This corporation shall have all the powers, general or specific, specified, granted to or conferred upon corporations for profit under the provisions of Chapter 607, Florida Statutes, and all of the laws which are amendatory and supplementary to such law. The enumeration of specific powers herein shall in no way limit or restrict this corporation in the exercise of such powers.

### ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at one time is 1,000 shares of common stock, having a par value of \$1.00 per share.

### ARTICLE IV

The amount of capital with which this corporation shall begin business shall not be less than \$500.00.

### ARTICLE V

This corporation is to exist perpetually.

### ARTICLE VI

### ARTICLE VII






