# RESTATEMENT OF AND AMENDMENT TO THE ARTICLES OF INCORPORATION OF STEINBURG & MILANO INC.

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned, being all of the directors of STEINBURG & MILANO INC. (the "Corporation") hereby adopt the following Restatement of and Amendment to the Corporation's Articles of Incorporation:

- The name of the corporation is STEINBURG & MILANO INC.
- 2. The street address of the principal office, which is the mailing address, of the Corporation is:

5051 Castello Drive Suite 206 Naples, FL 34103

- The aggregate number of shares that the Corporation is authorized to issue is as follows
  - a. One Hundred Thousand (100,000) shares of common stock, and the par value of such shares shall be One Cent (\$0.01). Par value shall have no effect on the Corporation's capital structure;
  - Of the One Hundred Thousand (100,000) shares of common stock authorized, One Thousand (1,000) shares shall be voting common stock ("Voting Common Stock"); and
  - c. Of the One Hundred Thousand (100,000) shares of common stock authorized, the remaining Nincty-Nine Thousand (99,000) shares shall be non-voting common stock ("Non-Voting Common Stock"). The Non-Voting Common Stock shall have and enjoy the same rights, preferences and privileges as the Voting Common Stock, and shall, for all purposes, be and act as a single class of shares, except that the shares of the Non-Voting Common Stock shall not be entitled to vote on any matter, unless otherwise required by law. Each holder of the shares of Voting Common Stock shall be entitled to one vote for each share of Voting Common Stock shall not be entitled to vote on any matter by virtue of the holder holding such shares of Non-Voting Common Stock, unless otherwise required by law.

4. The street address of the registered office of the Corporation is:

6. The number of Directors constituting the Board of Directors of the Corporation is One (1). The number of Directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1).

This Restatement of and Amendment to the Articles of Incorporation was unanimously approved by the directors and shareholders of the Corporation; accordingly, the votes cast by the shareholders for this Restatement of and Amendment to the Articles of Incorporation were sufficient for approval.
