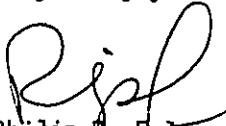

ARTICLES OF INCORPORATION
OF

MECHANICS MANAGEMENT CORPORATION

The undersigned incorporator to these Articles of Incorporation is a natural person competent to contract and does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I
NAME

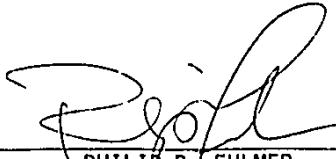

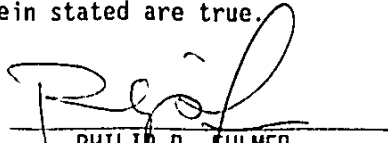
