ARTICLE I - NAME

The name of the corporation is Iges, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of filing.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK

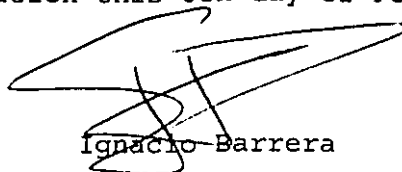

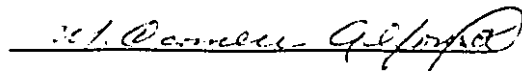
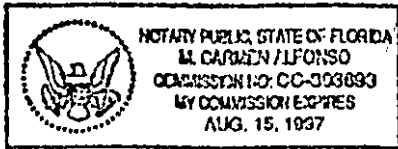
