ARTICLE I

CORPORATE NAME

The name of this Corporation is L T C GRAPHIC, INCORPORATED

ARTICLE II

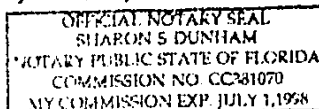
