ARTICLE I -- NAME

The name of this corporation is ABEL LANDSCAPING SERVICE, INC. with it's principle and mailing address being: 630 North East 59th Court Ft. Lauderdale, FL 33334.

ARTICLE II - DURATION

This corporation shall exist perpetually, unless sooner dissolved according to the law.

ARTICLE III - PURPOSE

This corporation is organized for the following purpose: TO CONDUCT THE BUSINESS OF LANDSCAPING AND LAWN CARE SERVICE; to buy and sell commercial paper and collateral; consummate and collect loans; own, manage and lease real estate and for the purpose of transacting any or all other lawful business permitted under the laws of the United States of America and the State of Florida.

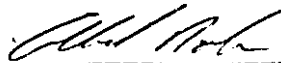

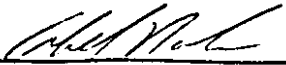
