



Article III of the Articles of Incorporation of Insurance News, Inc., is hereby amended as hereinafter provided. The Corporation is filing these Articles of Amendment to its Articles of Incorporation pursuant to Florida Statute Section 607.1006.


1. The name of corporation is Insurance News, Inc.
2. Article III of the Articles of Incorporation of Insurance News, Inc., is amended to read as follows:

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100,000 shares of common stock at no par value.

3. The foregoing Amendment to the Articles of Incorporation of Insurance News, Inc. was duly adopted by a unanimous vote of the Shareholders of this Corporation on March 22, 1996 after recommendation and approval of same by the unanimous vote of the Board of Directors of this Corporation on March 22, 1996. All Shareholders of the Corporation were entitled to vote on the aforesaid Amendment and all shares outstanding approved the Amendment.
