ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation shall be VIDEO BOX ADVERTISING, INC.

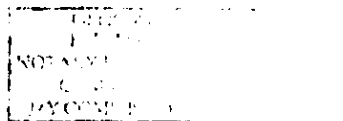
